### Registration Process:

- 1) Before registering for either of these courses you must first contact the Manitoba Real Estate Association to obtain approval
- 2) If registering for the *Salesperson Challenge* course, you will be required to register with The Manitoba Securities Commission within six months of course completion and may be required to complete the two additional mandatory articling courses after registration
- 3) If registering for the *Broker Challenge* course, you will be required to register with The Manitoba Securities Commission within six months of course completion and may be required to complete the Risk Management course prior to registration
- 4) Complete this registration form and submit it by email, fax or mail, along with payment to the MREA. Acceptable methods of payment are: cheque, Visa, MasterCard or money order.
- 5) Registrations received by email, fax, or mail will be processed with course timelines beginning the day the registration is received. Once payment is received by the MREA, the course materials will be sent to the student.
