This module takes place at MREA for two consecutive days of classroom study. Following the two-day classroom session, students are required to complete two online courses: *FINTRAC: Complying with Anti-Money Laundering & Counter-Terrorist Financing Obligations and Canada's Anti-Spam Legislation: Guidance for REALTORS®*. After successfully completing all components of Module 4 (classroom session and online courses) students may apply for their license with the Manitoba Securities Commission.
