The *Real Estate as a Professional Career* program is the education requirement to become licensed as a salesperson in Manitoba. The program consists of four modules. The salesperson licensing program, including any corresponding exams, assignments, and online courses, as well as any exam rewrites, must be completed within 16 months from Module 1 enrollment date. Modules 1-3 are self-study courses which are completed at each student's own pace.

Manitoba Financial Services Agency Licensing Requirements

To become a registered real estate professional, you must:

- Complete Modules 1, 2, 3, and 4 of the *Real Estate as a Professional Career* program within the designated timeline
- Be employed by a registered brokerage in Manitoba within 12 months of completing the education requirements
- Be at least 18 years of age
- Be a permanent resident of Canada. If you are not a Canadian citizen, you must provide documentary evidence showing that you are entitled to work in Canada
- Have a good past record of financial responsibility and conduct
- Submit the required forms and payment to The Manitoba Financial Services Agency
