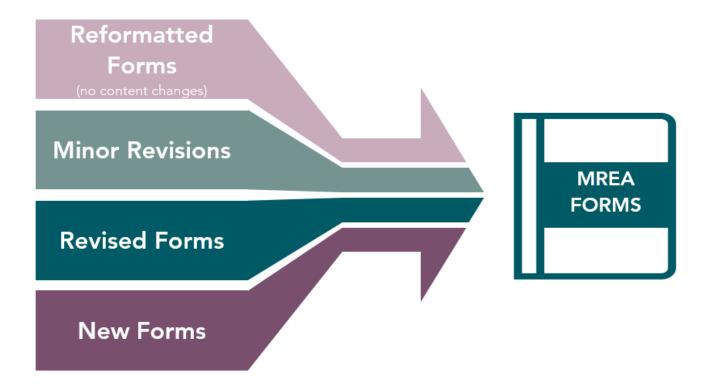

The Manitoba Real Estate Association Inc. (MREA) has a catalogue of over 50 forms that members can access for use in the industry. The MREA Forms Committee, comprised of experienced members and legal experts, recently conducted a review of some of the forms to ensure they align with current industry practices and adhere to the requirements as set out in *The Real Estate Services Act* and Regulation.

This guide contains forms that have recently been revised and/or reformatted by the committee. New forms recommended by the committee are also included. These forms will be available on CREA WEBForms®, MREA Online Education, and the Winnipeg Regional Real Estate Board's (WRREB) Keystone Portal.

In this guide the reformatted, revised, and new forms are categorized into four groups:

Purpose of Form:

This form is used when proof is required from a seller to establish:

- (a) whether they are (or are not) married or in a commonlaw relationship;
- (b) whether the person who has provided a homestead consent for the sale of a property (see the next form) is in fact the person who has homestead rights in the property, or;
- (c) that a property is <u>not</u> a homestead property. This form is Form 5 as prescribed under *The Real Estate*Services Act.

Form Name: Homesteads Act Consent to Disposition and Acknowledgement (Attached to Instrument)

Purpose of Form:

This form is used when a spouse or common-law partner has homestead rights in a property they do not own, and the owner requires their consent for it to be sold.

This form is created from Form 3 under *The Homesteads Act*. The wording will be familiar because it is similar to Form 2 under *The Homesteads Act* which is set out near the end of the current residential and condominium offer to purchase forms.

When the new residential and condominium offer to purchase forms are released by The Manitoba Securities Commission, it is expected that Form 2 under *The Homesteads Act* will no longer be imbedded within the offers. As a result, this new form (Form 3 under *The Homesteads Act*) will be used.

The use of this form will not likely be required until after the current offer to purchase forms are discontinued.

This form is used when a buyer and a seller consent to being represented by the same brokerage in a potential transaction. By using this form, the buyer or the seller acknowledge having been informed about the challenges inherent in joint representations. They then consent to the limited agency obligations the brokerage and its representatives owe to each party.

Form Revision:

- Among other revisions, this form now includes reference to how limited joint representation applies to competing buyers.

Purpose of Form:

This form is used to assist brokerages and their representatives in meeting their obligation when more than one offer to purchase is being presented to a seller. Section 8 of the competing offer directive published on The Manitoba Securities Commission website states: "In the interests of transparency, a listing salesperson must keep a list of all offers presented to the seller. The list will be maintained on a draft form provided by the MREA. The list should note the following:

- the number of offers presented to the seller
- the identity of the buyer agent/selling agent
- a notation of whether the offer was received in a sealed envelope
- a notation of whether sealed envelopes were opened in the presence of the seller
- the form will be signed by the seller and/or listing agent.

Form Revision:

- This is the "draft form to be provided by MREA" that is referred to in the directive.
- This form has been revised to specifically set out the requirements.

Personal Real Estate Corporations and CREA WEBForms®

When *The Real Estate Services Act* was enacted on January 1, 2022, it permitted registrants to incorporate and perform real estate services through a registered personal real estate corporation (PREC).

Unlike other jurisdictions in Canada wherein registrants are often allowed to display an abbreviated PREC name or a shortened form of the PREC name with an asterisk, The Manitoba Securities Commission requires that registrants in Manitoba providing services through a PREC display their fully spelled out registered name on industry forms and in their marketing materials.

For example, a registrant named John David Donald Smith-Jones who has incorporated and registered a PREC is required to display the following name: **John David Donald Smith-Jones Personal Real Estate Corporation.** This particular corporation name with spaces is 62 characters in length.

It was brought to our attention that the CREA WEBForms® system was defaulting to auto-populating abbreviated names on forms, a format that is often allowed in other jurisdictions, rather than autogenerating names in full as is required in Manitoba. MREA worked with CREA to ensure that this issue was resolved in a timely manner.

Further, we completed an internal audit of all MREA forms to ensure sufficient space is provided for PREC names.

A secondary audit was completed on CREA WEBForms® relating to digital text boxes to ensure that sufficient space was available for registrants' use. MREA completed testing on all its forms and identified the forms which required lengthier digital text boxes, something CREA's web team addressed promptly.

Change Your Default CREA WEBForms® Font Style and Size

Although text box sizes were increased, MREA members using CREA WEBForms® may be required to further adjust their font style and size to accommodate longer PREC names.

Steps to revise font styles and sizes are as follows:

- 1. Access the CREA WEBForms® Member Dashboard
- 2. Click on the profile icon on the right-hand side of screen to access **Settings**.
- 3. **Program Settings** → **Form Settings.** Here you will be able to change the default font style and size.
- 4. Confirm your new default settings by pressing the blue **Update** button.

Manually Revise Your CREA WEBForms® Font Style and Size

On some occasions, registrants may also want to manually adjust the font directly on the form being utilized. Fonts can be changed in each form as required by following these simple steps:

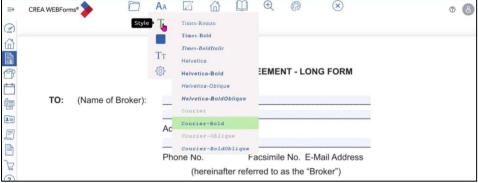
1. Open your preferred form.

2. Access the specific text box requiring text adjustment. Clicking on the field will generate a ribbon on the top of the screen.

- 4. Here you may manually select your preferred font style and select your font size.
